Placements for Good (PfG) offers forward thinking charities, public sector organisations and businesses a unique opportunity to work with talented university and college students from a wide range of backgrounds to progress sustainability. Recruitment, pre-placement training and on-going guidance from NUS' 20+ person sustainability team will ensure PfG positively impacts your core organisational purposes as well as enhancing positive environmental and social impact.

PfG provides fit-for-purpose placements that are genuinely beneficial to both students and hosts. We work with host organisations to plan meaningful programmes of work that will draw out sector specific knowledge developed through students' academic studies whilst increasing sustainability learning and action for all.

PfG supports the organisations we work with to implement tangible responses to the United Nations Sustainable Development Goals for 2030 (SDGs). Students will deliver sustainability projects alongside their placement, which could include: contributing to existing sustainability initiatives within your organisation; ethical supply chain analysis; recycling audits; staff training on sustainability; establishing a sustainability champions scheme etc.

*All costs exclude VAT; organisations will also need to pay National Living Wage (£7.83/hour) for all student placements unless the placement is accredited by the student's university or college. Cost including PAYE is based on an 8 week (35 hours/week) placement.

Organisations and students will be matched April – May 2019.**
